DIRECTIONS TO THE SHOW

Featherly Regional Park/Canyon RV Park is situated on the Northwest corner of the 91 Freeway and Gypsum Canyon Road in Anaheim, CA. Although the mailing address is on Santa Ana Canyon Road, you will find the park physically located on Gypsum Canyon Road. Because some of the Internet map programs are sometimes not quite accurate, we've added the following directions to help you get there without confusion.

From the West on CA-91 – Traveling eastbound on the CA-91 Fwy, pass Yorba Linda Blvd./Weir Canyon Road. Take Exit 41 for Gypsum Canyon Road. Turn left at the bottom of the off-ramp. Pass under freeway and turn left at the signal. This will lead you right into the park entrance.

From the East on CA-91 – Traveling westbound on the CA-91 Fwy toward Beach Cities, pass Green River Road. Take Exit 41A for Gypsum Canyon Road. At the bottom of the off-ramp continue straight through the signal into the park entrance.

Warning - the 241 toll road is now FasTrak only.
