DIRECTIONS TO FIELD TRIAL GROUNDS -

FROM Interstate Route 15: Take the Cajalco Rd. exit. Go East 9.2 miles on Cajalco Rd. and turn right on Lounsberry Road (SOUTH). Southern California Beagle Club is 0.3 miles on the right.

FROM Interstate 215: Take the Ramona Expressway exit toward Cajalco Expressway. 0.2 miles. Turn left onto Ramona Expressway. Ramona Expressway becomes Cajalco Expressway which becomes Cajalco Road, drive 7.0 miles and turn left on Lounsberry Road (SOUTH). Southern California Beagle Club is 0.3 miles on the right.

RUNNING ORDER OF THE TRIAL

The drawing of entries for all classes will take place on the field trial grounds at 7:30 AM (PST). Dogs must be present on the field trial grounds at the time of the drawing to be officially entered. OAAD & OAAB classes will run on consecutive days. Bitches in season are eligible to run in the OAAB class. The winners of all classes will run, if eligible, for absolute. The field trials will be held regardless of weather.

PRIZES

The Greater San Diego Basset Hound Club offers rosettes for all placements and NBQ in all classes—OAAD, OAAB, FC and a rosette for Absolute. Dog related prizes will also be awarded to all placements and NBQ

Competitors are advised that terrain, ground cover and weather are unpredictable. Good shoes, adequate layered clothing and extra water for humans and dogs to carry in the field are recommended. Do not leave dogs in vehicles unattended unless you are absolutely certain of their safety.
